1. What is the study about?

You are invited to participate in a study about the design of smart sex products. We hope to learn more about the way that Australian adults engage with the smart sex products, their reasons for doing so, and the positive or negative experiences associated with their practices.

2. Do I have to participate?

Being part of this study is voluntary. If you want to be part of the study we ask that you read the information below carefully and ask us any questions.

You can read the information below and decide at the end if you do not want to participate. If you decide not to participate this won't affect your relationship with La Trobe University or any other listed organisation.

3. Who is being asked to participate?

You have been asked to participate because:

- You are aged 18 years and older;
- You have self-identified that you use or design smart sex products;
- You are competent at communicating in English

4. What will I be asked to do?

If you want to take part in this study, we will ask you to partake in an interview. Interviews may take place either face-to-face, over the phone, or via Zoom. Face-to-face interviews will take place in a safe, public venue which provides sufficient privacy to discuss sensitive topics. It will take approximately one to two hours of your time to be part of this study.

Question topics include background information about yourself, your engagement and experiences with the design of smart sex products, the types of devices designed, and the benefits or risks you associate with smart sex products.

5. What are the benefits?

This study will provide a safe and respectful forum for you to reflect on your experiences and perspectives associated with the design of smart sex products.

The expected benefits to society in general are an increase in knowledge and understanding which will provide an informed basis for improving policy, regulatory, and educational responses in this area.

6. What are the risks?

With any study there are (1) risks we know about, (2) risks we don't know about and (3) risks we don't expect. If you experience something that you aren't sure about, please contact us immediately so we can discuss the best way to manage your concerns.

7. What will happen to information about me?

We will collect information about you in ways that will not reveal who you are. This means you cannot be identified in any type of publication from this study.

Where applicable, your audio recording will be destroyed after transcription. We will keep your other information, such as your consent form and de-identified transcript, for 5 years after the project is completed. After this time, we will destroy all of your data.

We will collect, store and destroy your data in accordance with La Trobe Universities Research Data Management Policy which can be viewed online using the following link: <https://policies.latrobe.edu.au/document/view.php?id=106/>.

We will publish information about you in ways that will not identify you in any type of publication from this study.

The personal information you provide will be handled in accordance with applicable privacy laws, any health information collected will be handled in accordance with the Health Records Act 2001 (Vic). Subject to any exceptions in relevant laws, you have the right to access and correct your personal information by contacting the research team.

8. Will I hear about the results of the study?

At the conclusion of this study, a short 2-3 page report providing a lay summary of the project will be provided on the study's website that you can access (www.tech-sex.com).

Findings from this study will be posted to this list. People can join this list without being identified as a study participant.

9. What if I change my mind?

If you participate in an interview, you can choose to no longer be part of the study at any time until four weeks following the collection of your data. You can let us know by:

1. Completing the 'Withdrawal of Consent Form' (provided at the end of this document);
2. Calling us; or
3. Emailing us

When you withdraw any information about you will be withdrawn from the research study.

Your decision to withdraw at any point will **not** affect your relationship with La Trobe University or any other organisation listed.
